

# NOMINATION PAPERS

**Completed Nomination Papers must be accompanied by:**

- *A deposit of \$200 in cash, certified cheque or money order. Certified cheques or money orders should be issued to “The Office of the Chief Electoral Officer”.*

**These forms must be completed and presented to the district Returning Officer by the close of nominations in order to become an official candidate for the electoral district for the pending election.**

## **Instructions for completing the Nomination Papers, which include the following forms:**

### **Form N-1**

- At least 10 electors qualified to vote in the stated electoral district must nominate a candidate stating the electoral district where the candidate is running, the candidate's full name (last name followed by first name, and political affiliation - if any). The candidate's name and political affiliation should be identical to the name and political affiliation the candidate wishes to have on the ballot paper.
- The Returning Officer must verify that these names are the names of Qualified Electors by reference to the voters list. Qualified Electors are Canadian Citizens, aged 18 years or more on polling day, and are an ordinary resident of the province and applicable electoral district.
- At least 10 electors must print their names, sign their names and provide their residence address in the spaces provided on form N-1.
- A Witness must be present to attest that the persons named on the form are qualified electors in the electoral district, as well as witness the candidate's signature upon completion of the form, unless the candidate is absent from the province. The Witness does not have to be a resident of the electoral district.
- The Witness must also sign this form stating that the candidate agreed to be nominated in the presence of the Witness, or that the candidate gave his/her consent to be nominated but is absent from the Province.

### **Form N-2**

- The Candidate's name, address and political affiliation must be completed and the Candidate must sign where indicated.
- The Returning Officer, a Justice of the Peace or a Commissioner for Oaths must sign where indicated.

### **Form N-3**

- The Candidate's name, political affiliation and information pertaining to: his/her nomination, Chief Financial Officer, Location of Records, Auditor, Deposit of Contributions, Persons Authorized to Accept Contributions, Other Authorized Persons and Certification must be completed.
- The Candidate must sign form N-3.

### **Form N-4**

- Complete this form only if a candidate is running without political affiliation and wants to omit the words "non-affiliated" from his/her election documentation and the ballot paper.
