

NOMINATION PAPERS

Completed Nomination Papers must be accompanied by:

- A deposit of \$200 in cash, certified cheque or money order.
- Certified cheques or money orders should be issued to "The Office of the Chief Electoral Officer".

These forms must be completed and presented to the district Returning Officer by the close of nominations in order to become an Official Candidate for the electoral district for the pending election.

Personal information on this form is collected under the authority of the Elections Act, 1991, and the Access to Information and Protection of Privacy Act, 2015. Inquiries regarding this collection should be directed to the Office of the Chief Electoral Officer's ATIPP Coordinator at (1-877) 729-7987.

Instructions for completing the Nomination Papers, which include the following forms:

Form N-1

- The Candidate's electoral district, name and political party must be printed at the top of the form.
- 10 electors qualified to vote in the stated electoral district must print their names, sign their names and provide their residence address in the spaces provided on form N-1. The electors who print and sign their names are nominating the Candidate to represent their district in the House of Assembly.
- The Returning Officer must verify that these names are the names of Qualified Electors by reference to the voters list. Qualified Electors are aged 18 years or more on polling day, Canadian Citizens, and are ordinarily resident in the province and applicable electoral district.
- A Witness must be present to attest that the persons named on the form are Qualified Electors in the electoral district, as well as witness the Candidate's signature upon completion of the form, unless the Candidate is absent from the province. The Witness <u>does not</u> have to be a resident of the electoral district.
- The Witness <u>must also</u> sign this form stating that the Candidate agreed to be nominated in the presence of the Witness, or that the Candidate gave his/her consent to be nominated but is absent from the Province.

Form N-2

- The Candidate's name, address and political affiliation must be completed and the Candidate must sign where indicated.
- The Returning Officer, a Justice of the Peace or a Commissioner for Oaths must sign where indicated.

Form N-3

- The Candidate's name, political affiliation and information pertaining to their: nomination, Chief Financial Officer, Campaign Manager, Location of Records, Auditor, Deposit of Contributions, Persons Authorized to Accept Contributions, Other Authorized Persons and Certification must be completed.
- The Candidate must sign form N-3.

Form N-4

Complete this form <u>only</u> if a Candidate is running without political affiliation and wants to omit the
words "non-affiliated" from their election documentation and the ballot paper.

Form N-5

- Please carefully follow the guidelines for formatting the Candidate's name.
- Signing the certification is a final sign off that the name and political party name (if applicable), as printed on the form, is the way the Candidate wants their name on the ballot.
- The candidate must sign form N-5.

CERTIFICATE OF CONFIRMATION OF CANDIDATE'S NAME FOR THE PURPOSES OF THE ELECTION BALLOT

(Elections Act, 1991, Section 70)



Confirming the way a Candidate's name should appear on the election ballot is an important part of the nomination process.

On the ballot, Candidates' names are listed in alphabetical order by last name. The name format is as follows:

LAST NAME, First Name ex: MITCHELL, Andrea

Political Party (if applicable) GHI Party

A Candidate's name <u>cannot</u> include a title, degree or other prefix or suffix but may include a nickname (*Elections Act, 1991,* section 70(6)).

Not permissible → Titles, such as: Dr., Captain, Reverend

Degrees, such as: BA, MBA, Ph.D.

Prefixes or suffixes, such as: Mr., Mrs., The Honourable, Jr., Sr.

Permissible → Nicknames, for example:

Gertrude McLean → MCLEAN, Trudy

Michael Lundrigan is commonly referred to as 'Mick → LUNDRIGAN, Mick

An initial after the first name, ex: **PENTLAND**, Laura M.

A first name and a middle name, ex: THAMES, Frederick John
