By-Election: Conception Bay East - Bell Island<br>December 2, 2010

On Wednesday, November 10, 2010, the Writ of Election was issued for a by-election in the electoral district of Conception Bay East - Bell Island. The election date was set for December 2, 2010, and was called to fill a vacancy which resulted from the death of Progressive Conservative Dianne Whalen on October 3, 2010.

The list of electors printed on November 1 was used as the preliminary list, containing 9835 electors. Updates to the list were made during the election period until 8 p.m. on Saturday, November 27 (advance poll day), when a final revised list containing 11,078 electors was subsequently printed. The final revised list identified electors who applied to vote by Special Ballot, who voted at the advance poll and who applied to be added to the list (as well as other changes such as elector moves or corrections to electors' names and/or addresses). On Sunday, November 28 the final revised list was given to the district Returning Officer for distribution to the political parties and candidates. The same list was used by the Returning Officer and all election officials as the official list of electors on polling day.

Nomination day was held on Monday, November 22 and three candidates were officially nominated: David Brazil for the Progressive Conservative Party, Joy Buckle for the Liberal Party and George Murphy for the New Democratic Party.

The advance poll was held on Saturday, November 27. There were two locations for advance poll voting, one on Bell Island and one in Portugal Cove-St. Philip's. Each of these voting locations contained two voting stations for a total of four.

A total of 107 Special Ballot applications were received and approved and 105 ballot kits were returned by the deadline of 4:00 p.m. on Saturday, November 27. This means that 98 per cent of ballots were returned to the Office of the Chief Electoral Officer (OCEO).

The preliminary count on election night resulted in 3988 votes cast. A total of 551 votes were cast at two advance polls; 105 votes were cast by Special Ballot; and 3332 votes were cast at 34 regular polls with a 36 per cent voter turnout. David Brazil received 2638 votes; Joy Buckle received 299 votes and George Murphy received 1043 votes. There were eight rejected ballots, three cancelled ballots and 386 electors were "sworn in" at the advance poll, by Special Ballot and on polling day.

The official addition of the votes was held on Sunday, December 5 at the district Returning Office. The official addition resulted in a change in the final vote count only for the Progressive Conservative Candidate, Mr. David Brazil as 2640, not 2638 as reported on election night. This change did not affect the overall results as reported on election night and Mr. David Brazil was declared elected and was sworn in as a member of the House of Assembly on Monday, December 20, 2010. The results of this by-election left representation in the House of Assembly with 43 Progressive Conservatives, four Liberals and one New Democrat.

The Chief Electoral Officer would like to extend appreciation to the district staff for overseeing an efficient by-election: Judy Lockyer-Shields (Returning Officer), Darlene Flight (Election Clerk) and Gwen Barrett and Marilyn Sheppard (Special Ballot Officers). Thanks are also extended to the rest of the district election workers and the staff at the Office of the Chief Electoral Officer for an excellent job.
