PREFACE

NASKAUPI

The resignation of Mr. Jim Kelland from the House of Assembly on May 22, 1992 resulted in a vacancy in the House of Assembly for the Electoral District of Naskaupi.

Subsequently on May 28, 1992 a Writ of Election ordering the election of a Member to serve in the House of Assembly for the Electoral District of Naskaupi was issued.

The Writ ordered nominations concluded by June 15, 1992 and the Election to be held on June 25, 1992.

Two candidates were nominated, one representing the Liberal Party and one representing the Progressive Conservative Party.

Mr. Edward Roberts of the Liberal Party was elected. He was sworn in as a member of the House of Assembly on July 9, 1992.
