HUMBER WEST BY ELECTION SUMMARY

On May 28, 2001 a Writ of Election was issued for a By Election to be held in the Electoral District of Humber West on June 19, 2001. The By Election was called to fill a vacancy created by the April 9, 2001 resignation of Mr. Paul Dicks.

The Revised List of Electors that was completed in August, 2000 was used as the Official List. There were 9331 registered electors on the Official List and another 964 electors sworn in on polling day.

Nomination day was held on Saturday, June 9, 2001 with three candidates officially nominated, namely: June Alteen for the Liberal Party; Kris Watton for the New Democratic Party; and Danny Williams for the Progressive Conservative Party.

There were a total of 83 applications for special mail in ballots received and approved and only 12 special ballots not returned to the Chief Electoral Office by the 4:00 p.m., Saturday, June 16, 2001 deadline.

The preliminary count on election night resulted in a total of 5030 votes cast. There was a total of 333 votes cast at one advance poll; 71 votes cast by special mail in ballot; and 4626 votes cast at 40 regular polls.

Ms. Alteen received 1215 votes, Mr. Watton received 186 votes and Mr. Williams received 3606 votes. There were a total of 23 rejected ballots and 6 cancelled ballots.

The official addition of the votes was conducted on Friday, June 22, 2001. The results remained unchanged from the preliminary results on election night. Mr. Williams was declared elected after the official addition of the votes and was sworn in as a member of the House of Assembly on Thursday, August 2, 2001. The results of both the Port De Grave and Humber West By Elections left representation in the House of Assembly with 29 Liberals, 17 Progressive Conservatives and 2 New Democrats.

The Office of the Chief Electoral Officer spent approximately \$55,000 in administering the By Election pursuant to the provisions of the legislation.

On May 28, 2001 a Writ of Election was issued for a By Election to be held in the Electoral District of Port De Grave on June 19, 2001. The By Election was called to fill a vacancy created by the March 28, 2001 resignation of Mr. John Efford.

The Revised List of Electors that was completed in August, 2000 was used as the Official List. There were 8948 registered electors on the Official List and another 1090 electors sworn in on polling day.

Nomination day was held on Saturday, June 9, 2001 with two candidates officially nominated, namely: Roland Butler for the Liberal Party and Ed Neil for the Progressive Conservative Party.

There were a total of 140 applications for special mail in ballots received and approved and only 6 special ballots not returned to the Chief Electoral Office by the 4:00 p.m., Saturday, June 16, 2001 deadline.

The preliminary count on election night resulted in a total of 6539 votes cast. There was a total of 448 votes cast at one advance poll; 134 votes cast by special mail in ballot; and 5957 votes cast at 38 regular polls.

Mr. Butler received 3309 votes and Mr. Neil received 3211 votes. There were a total of 19 rejected ballots and 12 cancelled ballots.

The official addition of the votes was conducted on Friday, June 22, 2001. The results remained unchanged from the preliminary results on election night. Mr. Butler was declared elected after the official addition of the votes and was sworn in as a member of the House of Assembly on Friday, July 6, 2001. The results of both the Port De Grave and Humber West By Elections left representation in the House of Assembly with 29 Liberals, 17 Progressive Conservatives and 2 New Democrats.
